The health and safety of patients is the **absolute priority for any hospital** and its team of dedicated professionals. Hospital acquired infections are also devastating to your facility and your operating costs.

In 2015, 2,592 hospitals were cited for poor readmission results, leading to a penalty of up to 3% of Medicare reimbursements. Moreover, each HAI event costs the involved hospital an average of \$23,000.

Reductions in Medicare payments to hospitals are

- projected to rise to 2% and above in 2017. Hospitals that fail to properly report these measures will be fined an additional 2% of their baseline Medicare payments. Bottom quartile-performing hospitals are also fined 1% of baseline
- 24% of professional liability costs for hospitals arise from
 HAI's. In one 2014 casealone, a Texas man was awarded
 \$17.5 million after a post-operative MRSA infection led to multiple amputations.
- 15.7 worker's compensation incidents recorded per 10,000 housekeeping/environmental services employees in the United States. These were caused directly from exposure to harmful substances, many of which can be found in cleaning products now widely used in hospitals.
